### **Important Instructions for candidates:**

- 1) It is mandatory to bring the following essential original certificates/documents to attend the counseling:
  - a. Matric (10<sup>th</sup> Class Certificate) of verification of age.
  - b. 10+1 Detailed Marks card or verification that candidate has studied Physics, Chemistry and Biology and English.
  - c. 10+2 Detailed Marks Card for verification of eligibility as per Punjab Govt. Notification and NEET UG-2020 Bulletin.
  - d. Punjab Residence Certificate.
  - e. Caste Certificate.
  - f. Exemption certificate (if any)
  - g. Other Reserved category certificates.
  - h. Copy of fee receipt.
  - i. Certificate from the Head of the institution where passed 10+1 and 10+2 examination.
  - j. Undertaking by parents/Guardian that child/ward not availed any residence benefit in any other state.
- 2) The tuition fee will be collected on the spot at counseling venue in the shape of Demand Draft in favour of Registrar, BFUHS, Faridkot payable at Faridkot, failing which seat will not be allotted.
- 3) The detail of tuition fee is available at Clause 14 of notification no. 5/9/2020-5HB-III/5234 dated 02.09.2020.
- 4) The fee for Adesh Institute of Medical Sciences & Research, Bathinda will be according to interim order of Hon'ble Punjab & Haryana High Court dated 18.09.2020 in CWP no. 14902-2020 titled Adesh University of Health Sciences, Bathinda and another Vs State of Punjab and CWP No. 20420 of 2020 titled Parneet Kaur Vs State of Punjab and others. This is subject to the final outcome of decision of Hon'ble Punjab & Haryana High Court.
5. **Eligibility for Stray Vacancy Round of Counseling**
  - a) **The candidates who are eligible for Stray Vacancy round of counseling**
    - All registered candidates except those mentioned at point (b) below
  - b) **The candidates who are not eligible for Stray Vacancy round of counseling**
    - The candidates who have been allotted a seat in MopUp Round.
    - The candidates who are holding/joined the allotted seats of Round I/Round II/MopUp Round.
