Note:

1. The candidates are required to bring all original documents comprising fee receipt, Photograph, qualification, experience, Age proof, Proof of Punjabi passed at Matric level, Academic certificate, Caste certificate, Residence certificate, etc along with photocopy of all testimonial. No separate correspondence shall be made in this regard by the university. Personal appearance of candidates is mandatory during document verification. Counseling fee Rs. 1000/- shall be charged from each candidate on the spot at counseling venue.
2. Candidate must fulfil the eligibility criteria for the post mentioned above.
3. In case, any certificate/testimonial of an applicant is found to be fake at any stage of recruitment or issued by an incompetent authority, the eligibility/appointment would be cancelled with immediate effect and legal action may be taken against him/her.
4. Appearance for document verification does not imply that candidate has fulfilled the entire criteria and he/she is eligible for the post. Eligibility of the candidate will be determined after through scrutiny of the application. If candidate is found not eligible by the document verification committee, he/she will not be allowed to appear in the interview/written test (whichever is applicable).
5. Candidate possessing incomplete documents/testimonials will be straight way rejected. Kindly ensure to produce all the original documents at the venue.
6. Only candidates who fulfils the eligibility criteria under document verification will be called for written test/interview (whichever is applicable).
7. Candidate will not be paid any TA/DA for attending the document verification/Interview/written test.
