**DISCLAIMER TO STUDENTS  
SEEKING M.B.B.S. ADMISSION IN PRIVATE  
MEDICAL COLLEGES  
IN ACADEMIC SESSION 2021-2022  
WITHOUT CENTRALISED COUNSELLING  
PROCESS BY THE UNIVERSITY**

The Stray Special Vacancy Round of admission to 150 MBBS seats at Chintpurni Medical College, Pathankot was concluded on 28.04.2022 at 10:00 pm on the basis of the norms and guidelines of the Government of India, DGHS and NMC. Since some seats had remained vacant, the said College approached the Hon'ble Supreme Court of India in W.P. (C) 331/2022, praying *inter alia* for extension of deadline for conducting admissions as well as direction to the BFUHS and other authorities for opening the portal to conduct fresh registrations and admissions. The said writ petition has been dismissed by the Hon'ble Supreme Court of India on 27.05.2022.

It has now come to light that Chintpurni Medical College, Pathankot is conducting the admissions at its own level on 28.05.2022 and 29.05.2022 without the centralised counselling process which was conducted by the University and ended on 28.04.2022. This is not legally permissible.

**Students are hereby informed that any such admission will be at their own risk and responsibility. Such irregular admissions that may be made by the College directly after the last date of admissions without the centralised counselling process conducted by the State counselling agency (i.e. BFUHS, Punjab) shall be reported for cancellation to the National Medical Commission, New Delhi and the Medical Counselling Committee, DGHS, Government of India.**
