  - i) Ms. Shabnam Masih (Applicant):- <u>Proposed subject of Ph.D. thesis</u> "An experimental study to assess Effectiveness of Dance Movement Therapy and Meditation on Aggression and the Social Competence among Adolescents in Selected Schools of Ludhiana, Punjab."

**RESOLVED:** It was suggested to re-submit the same after incorporating modifications in the research title and some other alterations as suggested by the members of RDC. The word "Aggression" has to be replaced by some other appropriate word in the research title. She has to improve the research methodology as it is not unambiguous and add the including study tool along with the consent form in the synopsis. She has to make use of the standardized tool with standardized inputs. She has to improve the review of literature and add the list of references in the synopsis.

ii) Ms. Rimple Ericson (Applicant):- <u>Proposed subject of Ph.D. thesis</u> "A quasi experimental study to assess the effect of Progressive Muscle Relaxation Technique and Laughter Therapy on Anxiety and Quality of Life of Adolescents in Selected Senior Secondary School, Ludhiana, Punjab

**RESOLVED:** It was suggested to re-submit the same after incorporating the modifications as suggested by the members of RDC.

iii) Riya (Applicant):- <u>Proposed subject of Ph.D. thesis</u> "A randomized control trial to assess the effect of No Mind Meditation Therapy (NMMT) on depressive symptoms, anxiety and locus of control among student nurses in selected institutions Ludhiana, Punjab".

**RESOLVED:** It was suggested to re-submit the same after incorporating some modifications. She has to rewrite the research methodology and add the observation sheet along with the consent form in the synopsis. She has to clearly mention the process of randomization and add the scales of measurement for Anxiety and Depression in the synopsis. She has to concise the review of literature and add the list of references in the prescribed format in the synopsis. She should also remove the grammatical mistakes.

iv) Ms. Preety Alagh (Applicant):- <u>Proposed subject of Ph.D. thesis "</u> A quasi-experimental study to assess the effectiveness of antenatal expression of milk at term versus conventional method of milk expression on lactational performance among postnatal women at selected hospital of Patiala, Punjab".

**RESOLVED:** It was suggested to re-submit the same after incorporating some modifications. It was suggested to have a co-guide in this study. She has to consider a broad range for the target population and increase the sample size up to 400 cases i.e. 200 cases in each of the two legs. She has to add the information brochure, observation sheet, assessment check list along with the consent form in the synopsis. She has to add development tool also in the synopsis and synopsis should be in university format.

v) Ms. Amanpreet Kaur (Applicant):- Proposed subject of Ph.D. thesis "
An experimental study to assess the Effect of Slow Yoga and Fast Yoga
Training on selected parameters of Pulmonary Function Tests among
women using biomass as cooking fuel in randomly selected villages of
