  - Senior Resident** maximum age must not be 45 years (As per NMC Notification dated 14.02.2022); provided that in case adequate eligible candidates for 45 or below are not available, candidates above the age of 45 years will also be eligible. Further provided that in case of qualified super-specialist (DM/MCh) there shall be no age limit.
