### 2. **ELIGIBILITY**

The bidders should be registered general merchant. The bidder should have a minimum turn-over of Rs.20.00 Lacs per annum in the last three financial years starting 2011-12, 2012-13 and 2013-14.

### 3. **QUALITY**

All the material should be Food Safety and Standards Authority of India (FSSAI) and/or Fruit Products Order (FPO) approved. The Diet material should be ISI/ISO certified.

### 4. **EVALUATION OF PRICE BID**

- i) The Price bids shall be evaluated on the basis of <u>lowest bid criteria</u> without compromising on the quality of material. Rates of all types of taxes as applicable during the contract period should be quoted clearly.
- ii) The Tenderer whose rate on overall basis for all kind of diet material are found lowest shall be given preference over other Tenderers. If no Tenderer quotes rates for all kind of gases, then only each item-wise L-1 shall be considered and multiple Annual Rate Contracts shall be determined.

### 5. **PERIOD OF CONTRACT:**

The Contract for supply of Diet Material shall be awarded to lowest bidder, initially for a period of one year which is extendable up to another one year subject to satisfactory performance of the firm and timely supply of the material and fulfillment of all terms and conditions.

### 6. **SECURITY DEPOSIT:**

The successful bidder shall be required deposit a security of an amount equal to 10% of the final bid amount in the shape of Demand Draft in favour of Principal, Guru Gobind Singh Medical College & Hospital, Faridkot drawn on any commercial/nationalized bank, payable at Faridkot, before signing of this agreement.

- 5. The Earnest Money Deposit will be refunded to the unsuccessful bidders within three months of the date of award of Rate Contract.
- 6. Merely issuing of bid document shall not constitute that the bidders are automatically qualified.
- 7. Even after award of contract, if, information/facts submitted by the bidders are found misleading/incorrect/false etc. Principal GGSMCH, Faridkot, reserves the right to disapprove / terminate the contract without any notice.
