## **Technical Specification for Digital Radiography & Fluoroscopy**

High powered X-ray unit with Digital flat panel for fluoroscopy and radiography examinations for the Department of Radio diagnosis at Guru Gobind Singh Medical College & Hospital, Faridkot (Pb).

The unit should be completely integrated system (integrated X-ray generator and image acquisition control) having the following specifications. At least two out of three components i.e. tube, X-ray generator and flat detector should be from the manufacturer of the system.

### **Generator**

- a) 1000mA unit with microprocessor controlled high frequency X-ray generator with power output of 80 kW or more
- b) Exposure kV range should be 40-150
- c) System should have facility for pulsed fluoroscopy
- d) Generator should have minimum exposure time of at least 1ms.
- e) System should have multiple user defined programmes (vendor defined programmes)
- f) There should be provision for automatic exposure control (AEC). It should be possible to override AEC if required

### **TABLE**

- a) Floor mounted table with radiolucent table-top with scratch resistant surface.
- b) Table should have a variable height for easy patient transfer. Please specify vertical range of movement in your offered model.
- c) System should have motor driven vertical, longitudinal and horizontal table-top movements. Please specify the range of movements.

e) Motorized copper filter for pre-filtration with minimum 3 selections should be possible.

## **Direct Digital Imaging system for Fluoroscopy:**

- a) Field of view of at least 40 cms or more.
- b) Collimator may be rectangular or iris type.
- c) System should have real time optimization techniques to maintain constant brightness at the lowest allowances dose to the patient.
- d) Cine / fluoro loop facility and last image hold facility.
