TECHNICAL SPECIFICATIONS FOR ROUND THE CLOCK TELE RADIOLOGY SERVICES (24X7):

- 1. The period of the work shall be for three (03) years from the date of issue of W/O / LOI, with an annual review of working.
- 2. The work is to be started immediately after issue of work order/LOI.
- 3. The Service Provider firm has to start the work, including online services, only after receiving the instructions from the Radiology In-charge.
- 4. The Competent Authority shall have the rights to cancel the W/O placed on a Service Provider firm in case the Service Provider firm fails to turn up for the work within 72 hours, as mentioned above or the progress of the work is not satisfactory.
- 5. The Service Provider firm shall not be allowed to transfer or assign the contract to any other person/company/firm.
- **6.** The services are to be carried out on 24 x 7 and on public holidays as well to meet the time of completion as per need of radiology deptt.
- 7. Service Provider firm does not have any right to make any claim for variation in the quantities.
- 8. All the works are to be attended as per the instruction of Radiology In-charge and whenever the quality of work is not up to the mark the same work has to be attended by the Service Provider firm on free of cost, however shut down for maintenance of Software will be given whenever required but not amounting to more than 12 hour on monthly basis and the same has to be intimated prior to the Radiology department.
- 9. The court in the city of Faridkot alone shall have the jurisdiction to entertain any suit, application claim or other proceedings in respect of any claim or disputes arising under this contract.
- 10. The Service Provider firm shall arrange proper safeguarding of the data against data theft and shall furnish account of the above as and when demanded. Any loss suffered by the Hospital on account of the above shall be deducted from the Service Provider firm bill.
- 11. Service Provider firm has to engage qualified technical person/supervisor for smooth execution of the work. He shall also intimate Radiology in charge the name of supervisor and also, in case of any change in the supervisor.

- 12. The Tele services provider company should make all necessary arrangements including software and hardware necessary for transfer image data. However high speed internet service provided by The Competent Authority in the Radiology Department at GGS Hospital, Faridkot.
- 13. Radiologist should be reputed Medical Practitioner with MD/DNB qualification and registered with respective state council/NMC.
- 14. The firm shall have an experience of minimum 03 years in the relevant field.
- 15. The cases reported by network will remain live hosted on server for one year after uploading.
- 16. The firm will comply with the confidentiality clause as per Medical regulation framed by NMC.

REPRESENTATIONS & WARRANTIES

17. The firm has to give an affidavit that they are not involved in any litigation with Government in India and there is no vigilance/ CBI case pending/ contemplated against them at the moment.

PENALTY CLAUSE

- 18. The Tele service provider company must ensure the highest standards of radiology reporting. The company should have their own quality check mechanisms. In case of any queries regarding the report / demand from the referring clinicians, the report will be sent back to the company & must be reviewed free of cost & reported back in two hours. Even after the reviewed/ revised report, the clinician is still not satisfied, it will be mandatory for the company to get second opinion from another Radiologist which shall also be free of cost. If the standards of reporting are not found up to the mark, the competent Authority reserves the rights of imposing additional penalty/legal actions against the company in such cases.
- 19. If any patient goes to the courts or files police complaint against any Tele Radiology report, the service provider company will be responsible for any financial or legal implications.

SERVICE TIME & REPORTING TURN AROUND TIME

- 2. Reporting turnaround time for the cases with proper images and clinical information shall be as follows:
