### 19. CRITERIA OF EVALUATION OF PRICE BID

The Price Bids of technically qualified bidders shall be evaluated on the basis of <u>lowest bid criteria</u> without compromising on the quality of material. However, it must be noted clearly that the Samples that are required to be enclosed along with the tender document will be considered as a part of the Technical Bid. The Rates quoted in the Price Bid must be inclusive of Carriage and all other charges, However, the Statutory Taxes will be paid extra, as per the Govt. rates (as applicable).

### 20. SECURITY DEPOSIT:

- i) EMD of Rs. 50,000/- only (Rs. Fifty Thousand ONLY) submitted by successful bidder with the Tender may also be considered as Security Deposit.
- ii) The Earnest Money Deposit will be refunded to the unsuccessful bidders within three months of the date of purchase order, without any type of interest.
- iii) The above said amount of the security deposit will be retained by the University and will be refunded after the receipt of all materials from the firm concerned in good quality.

#### 21. PAYMENT TERMS

The bill of the printed materials will be paid after receipt and inspection of the materials, through Account Payee Cheques/ NEFT/RTGS, in the favour of the seller/ dealer only. The payment will not be made to any third party under any circumstances.

#### 22. PENALTY CLAUSE

Material must be supplied within 30 days from date of approval of sample. If the supply is not made within the stipulated period then late delivery charges @2% will be imposed on the total amount of Supply Order up to delay of 30 days and thereafter @ 4% for another 30 days after which Supply Order/Rate Contract will be deemed cancelled & security/earnest money forfeited and company will be black- listed for future. However, the University can grant 15 to 30 days relaxation in the delivery period, based on the written request of the tenderer, if the University observes that the tenderer has valid reasons for non- supply of material within the stipulated time/ period.

### 11. ARBITRATION

- In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and/or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter whatsoever touching upon the terms and conditions of the agreement/contract whether in course of or after its termination the parties will settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Incharge, University Procurement & Facility Department, Baba Farid University of Health Sciences, Faridkot.
