SCOPE OF WORK

INSTALLATION, OPERATION & MAINTENANCE OF CT SCAN at Guru Gobind Singh Medical College, Faridkot under public private partnership (PPP)

INTRODUCTION

Guru Gobind Singh Medical College, Faridkot intends to outsource the services for CT Scan in its Hospital under Public Private Partnership for greater benefit of its patients.

The Bidders are to submit their bids for installation, operation and maintenance of this CT Scan centre along with an **Earnest Money of Rs. 2,00,000/-** (Rs. Two Lac Only). CT Scan installed must be of minimum specifications as per annexure A

I FOR THE TENDERER

- Tenderer will be responsible for the installation, operation and management of the above mentioned services under the agreement for a period of eight years. Extension in contract if any shall be at the request of the tenderer and at the sole discretion of Guru Gobind Singh Medical College, Faridkot.
- 2. Tenderer shall submit a certificate from the original equipment manufacturer (OEM) along with, the technical bid that the equipment and accessories to be supplied by OEM shall be original and brand new (The detail of the minimum capabilities of equipment required proposed to be installed by the tenderers are at annexure A). Tenderer should also enclose a certificate of assurance from the OEM of the equipment, that they will be able to supply the spare parts of the equipment for at least 08 years from the date of its installation.
- 3. That regarding filming Tenderer has to provide High Resolution Dry Camera matching the capabilities of main CT scan equipment. This is an essential requisite for the maintenance of the quality of films.
- 4. The alternative arrangement (as applicable) for **electricity** for running the diagnostic equipment in case of electricity interruption will be the sole

- 5. Guru Gobind Singh Medical College, Faridkot shall provide only space, all other works i.e. Civil, Public Health, Electricity etc, furniture, fixture, equipment etc. will be the liability of Tenderer including their maintenance. Tenderer will be required to install separate electric meter and pay consumption charges directly to the energy supplier as per prevailing rates of the energy supplier. Water supply will be provided free of cost
- 6. The equipment will be operated only by the qualified Technicians/ Radiologist as required by Laws/Acts applicable from time to time.
- 7. Tenderer will comply with all statutory requirements as applicable under the various central Act/Punjab Municipal Corporation Act.
- 8. Tenderer will comply with the Bio Medical Waste management and handling rules 1998 in the premises where the diagnostic facility is established.
- 9. Tenderer will put appropriate signage's (at the location of CT scan centre and space/area for dealing with patients and their relatives) indicating that the services are provided under PPP mode as approved by the Competent Authority indicating the name of the service provider/ Tenderer and address along with the mobile number for the convenience of the patients
 - A. Any and all stationary used by service provider/ Tenderer must be under the tenderers company letter head and use of GGSMC must be limited to be used in address and to specify PPP mode only.
 - B. While providing the services, no action of the tenderer should give an impression to the patient that the services are provided by GGSMC, Faridkot
 - C. All reports issued by service provider/ Tenderer should be on the letter head of Tenderer only. Clearly indicating that there is no responsibility of Guru Gobind Singh Medical College, Faridkot / Baba Farid University of Health Sciences, Faridkot
- 10. Tenderer will ensure that the paramedical staff deputed at the centre are in a proper dress code (including wearing of white aprons) as approved by the

- A. Penalty of \square 50/- shall be applicable if the staff found without proper dress including apron. Decision of the Guru Gobind Singh Medical College, Faridkot shall be final.
- 11. Patient seeking treatment where certain documentary evidences, are required to be maintained including for Medico Legal purpose etc., Tenderer shall be required to collect the required information and maintained such records for a period as required by law. Original of the same/scanned copy will be shared with Guru Gobind Singh Medical College, Faridkot by Tenderer within 24 hours of being required by Guru Gobind Singh Medical College, Faridkot
- 12. Tenderer shall keep the record of all Medico Legal Cases for future reference for the duration as required by law from time to time.
- 13.Guru Gobind Singh Medical College, Faridkot will collect the charges from the patients on behalf of Tenderer as per the rates finalized after the tender. 10% of the charges collected by the hospital shall be retained by the hospital for poor patients as per the policy of the hospital.
 - A. For other patients required to be provided free CT scan services under various national/state programs, medico legal cases or on account of other obligations of the Guru Gobind Singh Medical College, Faridkot, Tenderer shall be paid for the services provided as per finalsed rates (less 10% for poor patients) and Guru Gobind Singh Medical College, Faridkot shall be responsible to get such payments recovered/collected from respective agencies/state. Guru Gobind Singh Medical College, Faridkot shall be free to negotiate further and from time to time with Tenderer
 - B. Certain insurance companies may have a different schedule of charges, and services to be provided by the CT scan center (Tenderer) on different charges schedule, shall be subject to mutual consent however clause of 10% of poor free shall continue to be applicable.
 - C. If percentage of free patients is more than 10%, Guru Gobind Singh Medical

- D. If percentage of free patients is less than 10%, Guru Gobind Singh Medical College, Faridkot shall use the same in future for poor patients
- E. Patients referred from external agencies, hospitals and doctors directly to CT scan centre shall also have to get payments deposited at Hospital counters before CT scans are performed on such patients.
- F. Payments to Tenderer shall be done on monthly basis (by calendar month).
- 14. That the films and associated requirements will be the responsibility of Tenderer.
- 15. Duplicate films may be provided to patients at cost of $\hfill\Box$ 200/- per film of size 14" X 17".
- 16.CD/DVD shall be provided to each patient cost of which is to be included in the bid price
- 17. That the contrast (preferably non-ionic) of CT scan will be arranged and provided by Tenderer and the cost of which is included as defined in this tender documents elsewhere. Tenderer shall stock good quality contrast procured from an good quality manufacturer
- 18. That the operation of the CT scan machine will be round the clock (24 hours) no additional charges for emergency services shall be applicable.
- 19.That all reports shall have to be provided within 12 hrs of CT scan being performed and Tenderer shall ensure to get the report updated in Hospital Information System before the release of the report
- 20. That Tenderer shall make alternative arrangements in case of breakdown or any kind of force majeure.
- 21. That Tenderer shall make its own arrangement for Annual Maintenance Contract of the machine.
- 22. That the cost of repair and maintenance shall be borne by Tenderer.
- 23. Maximum duration for repair will be 5% per year i.e. 18 days per year. If breakdown/ repair is more than 5 % in a year, i.e., 5 days in 100 days), Tenderer will pay Rs. 10,000/- per day as penalty to the Guru Gobind Singh Medical College, Faridkot. resume the operations within 30 days from the date of breakdown of services, the Contract shall be liable to be terminated (at the discretion of Principal, Guru Gobind Singh Medical College, Faridkot) in addition to forfeiture of the security amount.

- 24. Tenderer shall not sell or transfer any Proprietary right or interest to any third party for running the diagnostic equipment in the health facility.
- 25. Tenderer is advised to maintain a third party liability policy to cover for medico legal risk and liabilities during the currency of the contract including for mishap at the machine.
- 26. Conforming to the provision of the consumer protection act shall be the sole and absolute responsibility of the Tenderer and Tenderer shall be liable for all the acts of commission/omission.
- 27. Teaching and training are important activity of to Guru Gobind Singh Medical College, Faridkot. To enable teaching and training:
 - A. GGS will be entitled to take extra films of patients having diagnosis of academic interest for teaching purpose subject to a maximum of 10 films per month.
 - B. Tenderer shall install and maintain a workstation with following minimum features in the radiology department for academic purpose with all full licensees (including all features) of all the software's mentioned below
 - i. Data and DICOM images of all the CT scans done in the past 30 days should be available in the workstation
 - ii. Data and DICOM images shall be made available on workstation immediately within 10 minutes
 - iii. Should have the option to burn CD/DVD of every study
 - iv. Certain patient of academic interest may require further detailed scan of specific area for which patient user charge slip has already been made. Detailed CT scan study of that area shall be allowed by Tenderer even after upto 30 days of initial scan at no additional charges. GGS shall limit such patient's upto 1% of the total patients.

- C. Tenderer shall allow free access to the authorized students at all times under supervision of hospital staff, however operation of the machine shall be exclusively by the technicians/radiologists of the Tenderer
- D. Tenderer shall allow free access to the radiologists of the Guru Gobind Singh Medical College, Faridkot, however reporting of the scans shall be done by the radiologists of Tenderer and may be done remotely using teleradiology.
- E. Tenderer shall support all types of academic activities by extending full cooperation for future requirement that may have not been mentioned or foreseen at this point of time
- 28. The equipment should qualify Bureau of Indian Standard (BIS)/Atomic Energy Regulation Board guidelines for Radiation safety.
- 29. The telephone and internet connectivity as required shall be procured by Tenderer at his/her cost and operational cost shall also be borne by Tenderer.
- 30. Tenderer comply to all the requirement of Atomic Energy Regulation Board (including QA at specified intervals by AERB), ELORA or any other regulatory body as applicable and required by law from time to time
- 31. Tenderer shall have to comply to all the existing and future requirements of National Accreditation Board of Hospitals and or Quality Council of India
- 32. ARBITRATION In the event of any dispute and difference arising out of or in any way touching or concerning this agreement what so ever shall be referred to the

II. <u>ROLE AND RESPONSIBILITIES OF Guru Gobind Singh Medical College,</u> <u>Faridkot</u>

- 1. The space as per applicable norms will be made available by Guru Gobind Singh Medical College, Faridkot to the Tenderer for running of these services
- 2. Collection of charges on behalf of the Tenderer and maintaining the records of the charges collected and also of the free patients.
- 3. Providing NOC to enable Tenderer to apply for electricity connection and generator. Expenses on separate electric meter for which the applicable security deposit and installation charges within the operating rooms under PPP will be borne by Tenderer. It may be noted that the any additional and separate wiring required for electricity load other than the current setup, shall have to be borne by Tenderer.

III. ROLE AND RESPONSIBILITIES OF TENDERER

- 2. Installation of electricity meter in its own name will be undertaken by Tenderer.
- 3. Tenderer will be responsible for maintenance of the machines and related equipments and comply with the norms for maintenance.

- 5. All the operational cost relating to functioning of each of the services including the cost of deployment of the personnel will be borne by Tenderer

- c. Ensure that his/her employees/staff are trained in BLS/ACLS
- d. Anaphylaxis is known to happen during contrast studies, and tenderer shall be responsible to provide due care to such patient till they are shifted to emergency by staff of tenderer.

IV. POLICY ON USER CHARGES AND FREE SERVICES

A. USER CHARGES

- 1. User charges will be collected by Guru Gobind Singh Medical College, Faridkot on behalf of the service provider/ Tenderer
- 2. Such charges shall be paid back to Tenderer after keeping 10% of the charges for poor free cases.
- 3. Rates should be prominently displayed by Tenderer in the facilities where these services are provided.

4. Tenderer may increase user charges every year by 5% (rounded off to nearest \Box 10/-) of the previous year applicable charges.

B. FREE SERVICES

The policy of free services shall be applicable to poor and vulnerable sections of the population. Free services will be provided to the poor patients as per the policy of Guru Gobind Singh Medical College, Faridkot. These patients will be referred by the Medical Superintendent on the recommendations of faculty of the hospital and associated hospitals.

V. MONITORING MECHANISMS

Performance review will be undertaken by Principal, Guru Gobind Singh Medical College, Faridkot or his/her representatives from time to time.

VI. CAUSES FOR TERMINATION OF AGREEMENT

Any of the following events shall constitute an event of default by Tenderer entitling Guru Gobind Singh Medical College, Faridkot to terminate this agreement:

- 1 In case of Failure to commence services in the Hospital within three months of signing the agreement.
- 2 Failure to comply with SOPs for operation and management of the services
- 3 Collecting charges from the patients in violation of the Policy on collection of user charges.
- 4 Error detected on more than two occasions in six months in recording the correct entry of the number of patients referred from the concerned hospital in each month.
- 5 Failure to comply with the statutory requirements of various central Act/Punjab Municipal Corporation Act.
- 6 Criminal indictment of the promoters, member/s of the Board of Directors, chief functionaries, key personnel engaged by Tenderer for operation and management of the services.

Tenderer will ensure that the services would be provided round the clock throughout the year for at least 95% of the time with maximum of 5% time to be spared for maintenance activities of the equipment. Thus maximum duration for repair will be 5% per year i.e. 18 days per year. If breakdown/ repair is more than 5 % in a year, i.e., 5 days in 100 days), Tenderer will pay Rs. 10,000/- per day as penalty to the Guru Gobind Singh Medical College, Faridkot. In addition to above, in case Tenderer fails to rectify the defects and resume the operations within 30 days from the date of breakdown of services, the Contract shall be liable to be terminated (at the discretion of Principal, Guru Gobind Singh Medical College, Faridkot) in addition to forfeiture of the security amount.
