# **TERMS AND CONDTIONS**

e-<u>TENDER DOCUMENT</u> for SSMA services of various photocopier machines of the University and its Constituent colleges/ Hospitals/ Institutions located at different locations throughout the state of Punjab, for one year and further extendable subject to satisfactory services and mutual consent of both the parties

- 1. The Manufacturers/ Sole agents/Authorized Dealers may quote their rates.
- 2. <u>Tenders will be submitted only through e-tendering mode. The tenders will not be submitted</u> <u>through any other mode, under any circumstances.</u>
- 3. Tenders without earnest money or short of it or not in the form specified above will not be entertained and shall be rejected straightway.
- 4. In-complete or conditional offers incorporating price variation will not be entertained.
- 5. Tenderer should certify in their offers that rates quoted by them are not higher than those quoted to DGS&D rates.
- 6. The supplier shall arrange to provide free sales service within the Guarantee/warranty period.
- 7. The firm should have its service center in Punjab.
- 8. The rates so quoted should have validity upto one year.
- 9. The quantity of item as mentioned above may be increased or decreased according to the requirement.
- 10. No tenderer shall be exempted from furnishing Earnest Money Deposit (EMD) under any circumstances.
- 11. Earnest Money/ Security Deposit and/or any other sum of the tenderer(s) lying with the Baba Farid University of Health Sciences, Faridkot or Guru Gobind Singh Medical College & Hospital, Faridkot in connection with any other tender/case shall not be considered against this tender.
- 12. The bids received after the specified date and time for receipt of bids will not be considered under any circumstance. Registrar, BFUHS, Faridkot shall not be responsible for any type of delay in submission of the e-tenders.
- 13. The rates once quoted will remain valid/ un-changed for a period of one year.



- 14. The tenderer will be responsible to ensure that the tender is properly uploaded and submitted within well in time. The Earnest Money Deposit must be submitted before the last date and time for opening of the technical bids.

- 17. Any conditional, telegraphic tenders, fax tenders, tenders without earnest money, and not in the prescribed form or in any deviation from the terms and conditions of the tender notice shall not be entertained and will be rejected out rightly.
- 18. The tenderer(s) shall be at liberty to be present, in person or through their authorized representative(s) at the time of opening of the tender as specified in the Tender Notice. In case the authorized representatives are to be present, they must furnish the authority letter from the tenderer, on whose behalf they are representing otherwise they will not be allowed to participate in the process of opening of tender.
- In case of violation of any of the terms and conditions as mentioned above, Earnest Money/ Security Deposit of the successful tenderer(s) shall be forfeited and the tender shall be cancelled.
- 20. Any attempt, direct or indirect, to cast influence, negotiate on the part of the tenderer with the official/authority to whom he will submit the tender or the tender accepting official/ authority before the finalization of tenders will render the tender liable for rejection.

Faridkot, Badal, Jalalabad, Shri Goindwal Sahib, Bathinda and should also include packing and forwarding charges, taxes and other levies.

22. The Registrar reserves all the rights to accept or reject any tender without assigning any reason and also to impose/relax any term and condition of the tender.

#### 23. CRITERIA OF EVALUATION OF PRICE BID

The Price Bids of technically qualified bidders shall be evaluated on the basis of <u>lowest bid</u> <u>criteria</u> without compromising on the quality of material. Rates of all types of taxes as applicable should be quoted clearly. The price bids of technically qualified bidders shall be evaluated on the basis of lowest bid criteria.

#### 24. SECURITY DEPOSIT:

- a. The EMD of Rs.10,000/- only (Rs. Ten Thousand Only) of successful bidder submitted with the Tender considered as Security Deposit.
- b. The Earnest Money Deposit will be refunded to the unsuccessful bidders within three months of the date of purchase order, without any type of interest.
- c. The above said amount of the security deposit will be retained by the University and will be refunded after completion of period of rate contract.
- 25. <u>Payment term</u>: Payment will be made through electronically transfer/ through cheque on six monthly basis after presentation of bill and completion of satisfactory services report from the respective persons identified by this office. TDS will be deducted as per rule. All taxes & other charges, if any, should be mentioned clearly; otherwise, the rates will be treated as all inclusive.
- 26. You will have to provide services at the place(s) (University & its constituent colleges) where the machines have already installed.
- 27. The service provider shall **provide direct service** and shall not employ sub-contractors.
- 28. The annual maintenance contract shall include periodic service, replacement of defective parts.
- 29. The photocopier machines shall be serviced periodically so that preventive action is taken for any possibility of malfunctioning/non-functioning of the same.
- 30. Complaints, if any, regarding functioning/non-functioning of the machines are to be attended expeditiously and in any case not later than a week. If the firm is not able to rectify the fault within a week's time from the date of booking the complaint, it would be open to the

department to have the fault rectified through any other source at the risk and cost of the service provider firm.

- 31. <u>Penalty clause</u>: In the event of defect remaining unattended for more than a week, a penalty of Rs.100/- per day per machine will be imposed on the firm.
- 32. Servicing, replacements, renewal etc. shall be carried out on site and only genuine spare part/assemblies shall be used for the purpose.
- 33. The firm shall be responsible for smooth and satisfactory working of the photocopier machines in all respects and will obtain certificate from the users that photocopier machines have been working satisfactorily during the relevant period.
- 34. The department reserves the right to increase or decrease the number of photocopier machines offered for annual maintenance contract.
- 35. As is evident from the list of photocopier proposed for SSMA, they are of different makes and models. it will be the responsibility of the tenderer/quoting agency to ensure that it is in position to timely supply authentic/company make spare parts of that make/model of photocopier, in case there is a need of that spare part for proper functioning of the photocopier. The tenderer should note that this office shall not separately write/arrange for any spare parts from the manufacturer/other sources for it.
- 36. In the matters of interpretation of any terms and condition or any dispute arising out of the maintenance contract the decision of department will be final and binding.
- 37. Initially contract/agreement period of SSMA of photocopier machines shall be for one year. However, the contract is extendable for a further period of one/two years on mutually agreed rates and terms and condition, at the discretion of the department.
- 38. The notice period for termination of contract shall be one month by either party. However, the service provider shall continue the service on same terms until a new service provider is identified.
- 39. The selected service provider shall, at the end of the service period/termination of contract hand over the photocopier machines in working condition to the successor service provider.
- 40. Before quoting the rate, the physical inspection of machine can be made, if desired by the firm.
- 41. Service provider should agree to provide service even on holiday, if required so.
- 42. A firm having outstanding with the University due to any other tender/work of the university is not eligible and will not be consider

#### 43. PENALTY CLAUSE

- A time period of 30 days will be given by the University to supply the material, depending upon the nature of item.
- If the supply is not made within the stipulated period then late delivery charges @2% will be imposed on the total amount of Supply Order up to delay of 30 days and thereafter @ 4% for another 30 days after which Supply Order/Rate Contract will be deemed cancelled & security/earnest money forfeited and company will be black-listed for future. However, the University can grant 15 days relaxation in the delivery period, based on the written request of the tenderer, if the University observes that the tenderer has valid reasons for non- supply of material within the stipulated time/ period.
  - If the Successful bidder refuses or does not respond to the instruction/orders with in stipulated period, the EMD shall be forfeited and order may stand cancelled.
  - If the firm refused to execute the orders fully or partially, the security amount shall be forfeited and supply order may stand cancelled.

#### 44. <u>ARBITRATION</u>

- i) In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and/or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter whatsoever touching upon the terms and conditions of the agreement/contract whether in course of or after its termination the parties will settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Incharge, University Procurement & Facility Department, Baba Farid University of Health Sciences, Faridkot.
- ii) In the event the said mutual discussions/conciliation fails, the aggrieved party shall initiate arbitration proceedings for resolution of differences/disputes etc., mentioned above by appointing a sole arbitrator, who shall be the Registrar, BFUHS, Faridkot in which event the said proceeding shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act enforce.
