SPECIFICATION OF HOSPITAL FOWLER BED

1. Bed should have 4 sections top made of CRCA sheet 16SWG i.e. 1.62mm thick press bent uniformly perforated.
2. The overall dimensions shall be as under :-
Length =2015mm +/- 10mm Min. (including channels)
Width =965mm +/- 10mm Min. (including channels)
Height =600mm +/-10mm Min. (Including wheel)
Head bow= 900mm +/- 10mm (Min). (Height from ground level.)
Leg bow = 850mm +/-10mm (Min.). (Height from ground level.)
3. Backrest and knee sections shall be maneuvered smoothly & easily by two separate levers. These shall have angular movement of 70 degree and 24 degree for back rest and knee rest respectively. The spindles providing such movements shall be encased in ERW pipe having 32mm dia x 2mm thick.
4. Both leg bow and head bow sides shall be fabricated out of S.S 304 grade 32mm dia. 16 SWG thick pipe. These shall have three numbers vertical supports of S.S 304 Grade 19mm dia.x16SWG thick pipe or shall be of ABS material.
5. Head section should be capable of being raised to the angle of 80 degree from the horizontal. Top of the head section should be fitted with X-Ray permeable minimum 8mm thick sheet and should have S.S. X-Ray cassettes holding tray adjustable by separate screw mechanism with thrust bearing.
6. The bed shall be fitted with four numbers heavy duty solid rubber swivel caster wheels of size 100x32mm. Two numbers wheels shall be provided with brakes. The fork of all the caster wheels shall be of S.S 304 grade.
7. There should be 4 saline rod locations and 1 stainless steel 304 grade telescoping saline rod 10mm dia provided with each bed.
8. **Frame Work:** - Complete frame work should be of CRCA rectangular pipe of size 30x60mmx 1.6mm thick
