- 4. No tenderer shall be exempted from furnishing Earnest Money Deposit (EMD) under any circumstances. The Earnest Money must be submitted in the shape of a Demand Draft issued in the favour of the Registrar, Baba Farid University of Health Sciences, Faridkot and payable at Faridkot. The demand draft of the EMD must reach to the office of the Incharge, University Procurement and Facility Department on or before the last date / time of opening of the technical bids.

18. CRITERIA OF EVALUATION OF PRICE BID
