Upgrades would mean product upgrades, engine updates, virus definition updates as well as version updates. The facility of updates and upgrades should be available on OEM website.
- The services shall be consisting of advanced tools with online management services to protect End-Users from email borne viruses and spam by scanning all incoming e-mails at the Internet level and passing it through an advanced filter system. The filter system shall scan for threats using the most up-to-date technology. The services will also pass the messages through a number of generic security filters and specialized e-mail heuristics to block whole classes of security risks and protect users from new threats. All messages to be scanned with spam filter, which will label potential spam or block it completely.
- 10. The firm shall provide 24x7 phone and chat support for the software.
- 11. The firm should mentioned the validity period i.e. one year, Two year or above.
- 12. Renewal charges on expiry of validity period should also be mentioned.
- 13. There shall be a provision of re-registration of client/server key in the event of break down/re-installation of a particular client/server.
