#### **SPECIFICATIONS**

# Specification of Hospital Semi Fowler Bed along with accessories

- Bed should have 2 sections top made of CRCA sheet 16SWG i.e. 1.62mm thick press bent uniformly perforated.
- 2. The overall dimensions shall be as under :-

Length =2015mm +/- 10mm Min. (Including channels)

Width =965mm +/- 10mm Min. (Including channels)

Height =600mm +/- 10mm Min. (Including wheel)

Head bow =900mm +/- 10mm (Min). (Height from ground level.)

Leg bow =850mm +/- 10mm (Min). (Height from ground level.)

- Backrest sections shall be maneuvered smoothly & easily by separate levers. These shall
  have angular movement of 70 degree for back rest. The spindles providing such
  movements shall be encased in ERW pipe having 32mm dia x 2mm thick.
- Both leg bow and head bow sides shall be fabricated out of S.S 304 grade 32mm dia 16 SWG thick pipe. These shall have three numbers vertical supports of S.S 304 Grade 19mm dia. x 16SWG thick pipe or shall be of ABS material.
- The bed shall be fitted with four numbers heavy duty solid rubber swivel caster wheels
  anti static in nature of size 100x32mm. Two numbers wheels shall be provided with
  brakes. The fork of all the caster wheels shall be of S.S 304 grade.
- There should be 4 saline rod locations and 1 stainless steel 304 grade telescoping saline rod 10mm dia provided with each bed.
- Frame Work:- Complete frame work should be of CRCA rectangular pipe of size 30x60mm x 1.6mm thick.



- Tube ERW 31.75mm O/D x 1.6mm thick (1 ¼" x 16SWG) vertical pipe and horizontal pipe 25.4mm x 16SWG.
- Chart Holder:- A detachable patient chart holder fabricated out of stainless steel sheet
   1.25mm thick with clamp shall be provided.
- 10. Side Railing:- The bed shall be provided with two numbers Stainless Steel 304 quality pull down side rails with pull to turn mechanism fabricated out of 19mm dia.x 1mm thick S.S tube at both sides.
- 11. Bed Mattress:- The bed shall be provided with 2 Sectional 4" thick "PU" foam mattress having density 32 (Min) duly covered with superior quality rexine cover 1mm thick.
- 12. Finishing:- All the components should be rust free and should have powder coating finish. Thickness of the coating should not less than 45 micron.
- Nut & Bolts:- All nut and bolts used in assembling the Semi Fowler bed shall be made of Stainless Steel.
- Ground Clearance: The bed shall have ground clearance of 165mm min. to provide high degree of stability.
- 15. S.S Wire Cage Basket:- A detachable type wire cage basket of size 535mm (L) x 280mm (H) x 50mm (D) for placement of X-rays, CT Scan, MRI film and other vital records of patients, fabricated from S.S 304 grade 3mm diameter wire welded at equal intervals of 25mm (Horizontally and Vertically) shall be provided at the foot end side of the bed. The basket shall be hang able on the upper pipe of leg bow frame.
- 6. Color:- White/ Cream Color.
- 7. Essential Accessories:- Urine Bag Holder/Hook-4 in Number (Two on each side)

- 2. <u>Tenders will be submitted only through e-tendering mode. The tenders will not be</u> submitted through any other mode, under any circumstances.
- 3. Tenders without earnest money or short of it or not in the form specified above will not be entertained and shall be rejected straightway.
- 4. Earnest Money/ Security Deposit and/or any other sum of the tenderer(s) lying with the Baba Farid University of Health Sciences, Faridkot or Guru Gobind Singh Medical College & Hospital, Faridkot in connection with any other tender/case shall not be considered against this tender.
- 5. The bidders are requested to quote the basic prices that must contain the FOR/ Delivery/ Freight Charges. However, the Taxes as applicable will be paid extra on the Govt rates.
- 6. The bids received after the specified date and time for receipt of bids will not be considered under any circumstance. Registrar, BFUHS, Faridkot shall not be responsible for any type of delay in submission of the e-tenders.
- 7. Minimum delivery period must be quoted clearly in the offer.
- 8. The rates once quoted will remain valid/un-changed for a period of one year.
- 9. The tenderer will be responsible to ensure that the tender is properly uploaded and submitted within well in time. The Earnest Money Deposit must be submitted before



the last date and time for opening of the technical bids.

- 10. Each page of the tender document should be signed in full by the tenderer(s) and should bear the rubber stamp/seal of the firm affixed/ scanned, if applicable, on each page. Any cutting(s)/overwriting(s) etc. should also be initialed. In case of any infringement of these conditions, the tender is liable to be rejected. - 11. In the event of the date of receipt or opening of tender being declared a holiday for the Baba Farid University of Health Sciences, Faridkot, the last date of receipt/opening of the tender shall be the next working day at the same time and venue. - 12. Any conditional, telegraphic tenders, fax tenders, tenders without earnest money, and not in the prescribed form or in any deviation from the terms and conditions of the tender notice shall not be entertained and will be rejected out rightly.
- 13. The tenderer(s) shall be at liberty to be present, in person or through their authorized representative(s) at the time of opening of the tender as specified in the Tender Notice. In case the authorized representatives are to be present, they must furnish the authority letter from the tenderer, on whose behalf they are representing otherwise they will not be allowed to participate in the process of opening of tender.
- 14. In case of violation of any of the terms and conditions as mentioned above, Earnest Money/ Security Deposit of the successful tenderer(s) shall be forfeited and the tender shall be cancelled.
- 15. Any attempt, direct or indirect, to cast influence, negotiate on the part of the tenderer with the official/authority to whom he will submit the tender or the tender accepting official/ authority before the finalization of tenders will render the tender liable for rejection.

17. The Registrar reserves all the rights to accept or reject any tender without assigning any reason and also to impose/relax any term and condition of the tender.

### 18. CRITERIA OF EVALUATION OF PRICE BID

The Price Bids of technically qualified bidders shall be evaluated on the basis of <u>lowest bid criteria</u> without compromising on the quality of material. Rates of all types of taxes as applicable should be quoted clearly.

#### 19. **SECURITY DEPOSIT:**

- i) The successful bidder shall be required to deposit a security of Rs. 1,00,000/- in the shape of Online Payment in favour of Registrar, Baba Farid University of Health Sciences, Faridkot
- ii) OR EMD of Rs.1,00,000/- submitted with the Tender may also be considered as Security Deposit, as agreed by the successful bidder.
- iii) The Earnest Money Deposit will be refunded to the unsuccessful bidders within three months of the date of purchase order, without any type of interest.
- iv) The above said amount of the security deposit will be retained by the University and will be refunded after completion of period of one year.

#### 20. PAYMENT TERMS

Payment will be made after delivery and Inspection of material in the Stores by the concerned committee.

### 21. **PENALTY CLAUSE**

A time period of 30 days will be given by the University to supply the material, depending upon the nature of item. If the supply is not made within the stipulated period then late delivery charges @2% will be imposed on the total amount of Supply Order up to delay of 30 days and thereafter @ 4% for another 30 days after which Supply Order/Rate Contract will be deemed cancelled & security/earnest money forfeited and company will be black- listed for future. However, the University can grant 15 days relaxation in the delivery period, based on the written request of the



tenderer, if the University observes that the tenderer has valid reasons for non-supply of material within the stipulated time/period.

### 22. **ARBITRATION**

- In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and/or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter whatsoever touching upon the terms and conditions of the agreement/contract whether in course of or after its termination the parties will settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Incharge, University Procurement & Facility Department, Baba Farid University of Health Sciences, Faridkot.
- ii) In the event the said mutual discussions/conciliation fails, the aggrieved party shall initiate arbitration proceedings for resolution of differences/disputes etc., mentioned above by appointing a sole arbitrator, who shall be the Registrar, BFUHS, Faridkot in which event the said proceeding shall be conducted in accordance with the provisions of the Arbitration and Conciliation Actenforce.
- iii) The venue of such arbitration proceeding shall be at Faridkot and the court in Faridkot alone will have jurisdiction in respect of all proceedings connected there with.
- **23. Jurisdiction** All disputes are subject to the jurisdiction of courts at Faridkot only.
